The Opportunity

In response to the profound impact of the COVID-19 pandemic on education systems nationwide, the federal government introduced a series of stimulus packages to provide critical funding to aid states' education recovery efforts. These emergency resources pave the way for districts to reopen schools safely, get students back into classrooms, and begin working to address unprecedented learning loss. Broward County, the sixth largest and most diverse school district in the U.S., sought an experienced partner to implement a comprehensive approach to equitable education recovery for students and families most impacted by COVID. The district selected long-time partner, Public Consulting Group (PCG), to design and implement a robust recovery plan integrating technology, direct student services, organizational change management, and a range of supports to meet the needs—both basic and complex—of students, teachers, leaders, and families.


The Solution

Each week, key thought leaders from Broward, PCG, and other stakeholders convene in an Equity Co-Lab to review dashboard data, collaborate on sustained innovation, and align resources to support every learner to success.

The Result

In Fall 2021, as part of the education recovery program, PCG's team made 30,610 phone calls to families of students who were missing or absent from class, as identified by the district. The team also joined more than 400 local educators and district leaders during a Weekend of Action, knocking on 8,101 doors in an effort to reengage young people in their education. In all, PCG's team helped Broward make contact with families of 7,893 young people identified as missing or absent by the district.

As of October 2021, over 1,000 students had reengaged with the district and were back in classrooms where they are on track to grow, learn, and reach their highest potential. These efforts also yielded an increase of over \$8M in state aid.

PCG's team is now deploying more than 60 tutors into 12 high needs schools to address learning loss gaps from interrupted instruction. The team looks forward to continuing this important work with Broward County Public Schools through the 2021-22 school year, and beyond.
